IOSH Managing Working At Height

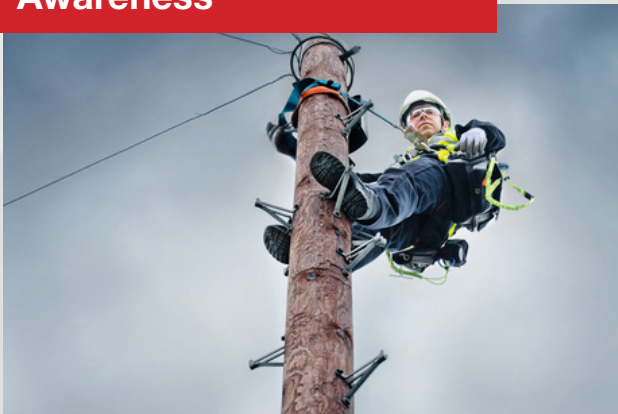


Course Aim:
